**Methods and material for containment and cleaning up**

<b>Minor Spills</b>	Control personal contact with the substance, by using personal protective equipment. Clean area with large quantity of water to complete clean- up.

## Information on toxicological effects

Inhaled	The material is not thought to produce adverse health effects or irritation of the respiratory tract (as classified by EC Directives using animal models).
Ingestion	Accidental ingestion of the material may be damaging to the health of the individual. Isothiazolinones are moderately to highly toxic by oral administration.
Skin Contact	Evidence exists, or practical experience predicts, that the material either produces inflammation of the skin in a substantial number of individuals following direct contact, and/or produces significant inflammation when applied to the healthy intact skin of animals, for up to four hours, such inflammation being present twenty-four hours or more after the end of the exposure period. The material may accentuate any pre-existing dermatitis condition Skin contact is not thought to have harmful health effects (as classified under EC Directives); the material may still produce health damage following entry through wounds, lesions or abrasions. Aqueous solutions of isothiazolinones may be irritating or even corrosive depending on concentration. Solutions containing isothiazolinones may produce corrosion of the mucous membranes and cornea.

Oxiranes (including glycidyl ethers and alkyl oxides, and epoxides) exhibit many common characteristics with respect to animal toxicology. for 1,2-butylene oxide (ethyloxirane): Ethyloxirane increased the incidence of tumours of the respiratory system in male and female rats exposed via inhalation.
ALCOHOLS C11-15 SECONDARY ETHOXYLATED	Polyethers, for example, ethoxylated surfactants and polyethylene glycols, are highly susceptible towards air oxidation as the ether oxygens will stabilize intermediary radicals involved.
